Added resolutions received from PEI & Centreville Clubs

1) MTTPA club Fee's – it was decided that we would suggest that the MTTPA increase their yearly club fee due to the rising cost of everything our club must do. Hopefully an adjustment will help us follow some of the recent inflation we have seen. We decided not to put a number on this adjustment but instead leave it up for discussion during the annual meeting.

2) MTTPA Pullers annual membership fee: On this topic we would like to make a resolution to move to \$100.00 per year from \$65.00 for full membership and \$50.00 per year from \$30.00 for single event membership.

3) We would like to suggest that there be a set out description on how our Dyno operator and our Teck Person handle stock tractor DQ's. For Example: our dyno operator can and will disqualify any tractor reading over on his dyno reading. But it will be the responsibility of our Teck Person to DQ any stock tractor or other pulling unit operating outside our rules on the track. It will also be the responsibility of our Teck person to assist the dyno operator in watching that pullers are operating their engines in the same manner on the dyno as they are on the track.

4) We would also like to ask that there be an effort made to be sure that all vehicles are teched at least once per year, with emphasis on the newer vehicles early in the season. Having said this because we are largely a puller run organization, each puller who is bringing a new vehicle to one of our events should also have a responsibility to make the tech person aware of their new vehicle upon arrival at their first event.
